Spudded well 12:00 noon 26 October 1975. Drilled 17-1/2" hole to 373'. Cemented 13-3/8" 54# J-55 casing @ 373' with 380 sx. Class "C" cement containing 2% CaCl₂. Circulated out 35 sx. cement. Plug down @ 9:30 AM October 27, 1975. WOC 24 hrs. Tested casing with 500 psi for 30 mins. with no decline in pressure. Drilling ahead with 12-1/2" bit.
