TD 11,782' PBTD 11,760', Ran 4-3/4" bit. Cleaned out top of liner at 9982'. Tested W/2000 psi for 30 minutes. No loss in pressure. Drilled out cement from 11,704' to 11,760'. Tested liner, 7-5/8" casing and BOP 2/2500 psi for 30 mins. No loss in pressure. Prep to proceed with Morrow completion.
