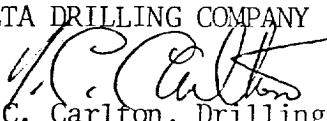


Morris R. Antweil - "XL" No. 1, Eddy County, New Mexico

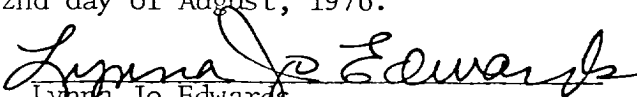
