The water flows from the Estill AD Federal Well No. 1 (API No. 30-015-22118) to a storage tank located on the well site. The produced water is transported off-lease by Rowland Trucking Co. to the BKE #1 salt water disposal well. The disposal well is owned and operated by Rowland Trucking Co. and is located in Section 13, T22S-R27E, Eddy County, NM. (SWD permit number 495).

Chevron's produced water delivery point is located on the well site.

Water production for the Estill AD Federal Well No. 1 is approximately 1 BPD.
