 3. Spot 30 sx Class "A" cement @2632' (calc. fillup 395' to 2237')
 4. Set CIBP @2280' capped w/10 sx. Class "A" cement (Calc. fillup 132' to 2148')
 5. Cut off 4 1/2" csg. & 8 5/8" Bradenhead.
 6. Spot 10 sx. plug 130' to surface
 7. Installed dry hole marked
 8. Cleaned up pits and location.
