Spudded 10" hole at 12:00 noon, March 20, 1979 and drilled to total depth of 375' in shale and gyp on March 24, 1979. Ran 10 joints of 24#, J-55, 8-5/8" casing, 367', set at 370'. Cemented with 250 sacks Class C with 2% CaCl₂. Circulated out 70 sacks excess cement. Plug down at 9:30 a.m. March 24. Let cement set 24 hours. Bailed casing dry and drilled cement in casing and shoe. Bailed casing dry. No fluid entry in casing after 1 hour. Drilled ahead at 11:00 p.m. March 25.
