Sept. 9, 1981: Rar Lynes Eridge Plug in hole on 2 7/8 tubing. Set Bridge Plug at 11,200'. Spot 10 sx. cement plug on top of Bridge Plug.

Spot Cement Plug (40 sk.) at 9,614'. Tag up. Spot cement plug 40 sk. 4/10 of 1% CFA-2 CL. H. Cement at 7,660'. Shut down to 20' up. Top of plug at 7,490'. Displace hole with 2% KCl Water. Run Schlumberger (Spectrograph Log) 7,328' up to 5,528'. Wireline T.R. 7,583'.

Perf. 9 5/8 casing as follows: 1 shot per foot. 6164 to 75, 6252-42, 6290-6303, 6352-58, 6367-92, 6550-58, 6627-34, 6656-90, 6738-52, 6790-6812, 6904-14, Total 171 no. ea.
