

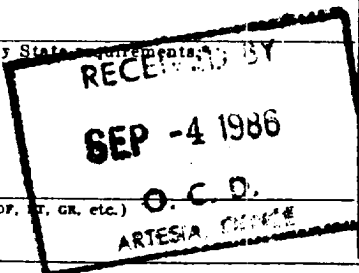

T.D. 1125' Sand, PBTD 604'. This well was plugged and abandoned in the following manner:

1. MIRU a pulling unit and RIH w/OE'd tubing to 348' and circulated hole w/mud laden fluid. Spotted a 30 sack Class C Neat cement plug @ 348 - 223', 1/2 in and 1/2 out of the 7-5/8" casing shoe @ 298'. POOH w/tubing and WOC.
2. RIH w/tubing and tagged cement plug @ 237'. Pulled tubing to 60' and set a 15 sack Class C Neat cement surface plug @ 60 - surface. Cut off WH and installed a 4" dry hole marker to designate a plugged and abandoned location.

Bottom hole plugs @ 1125 - 1025' and 704 - 604' had been set in August, 1980 and this well had been retained as a fresh water supply well until the present time.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
