Moved in service unit 8-26-81. Ran cast iron bridge plug and set at 12380' and capped with 35' cement. Ran tubing to 9256' and displaced with 10# brine water. Pumped 40 sx cement plug and plug top at 9011'. Pulled tubing. Ran correlation temperature base log 8200-6200'. Perforated Bone Springs 6964'-69', 6948'-56', 6933'-36', 6878'-93, 6849'-64 6793'-6836', 6733'-78', 6724'-27', 6715'-20 with 15PF. Ran packer, tubing, packer set at 6487, and tailpipe at 6612'. Acidized with 7000 gallons 15% HCL acid and ball sealers. Swab tested for 15-1/2 hours and recovered 113 BLW and 3 B0. Fractured 6715'-6969' with 13500 gals 40#/gal, 55000 gals CO2, 45000# 20/40 sand and tagged with radioactive material. Flushed with 55 BBL gel and CO2. Swab tested for 27 hrs. and recovered 150 BLW. Currently swab testing.
