12/16/81 - Ran tbg as follows: 2 jts mud anchor (bull plugged)-63.20', perf sub-3', seat nipple-1.10', 16 jts tbg-516.15', Baker 4-1/2" tbg anchor-3', 193 jts tbg-6174.11'. Bottom of mud anchor-6760.56'. Tbg anchor @ 6177.11'. Nippled down BOP. Set tbg anchor with 13,000# tension. NU tbg head & pumping tee. RU to run rods. WO rods 4 hrs. Unloaded rods. Started in hole w/pump & rods & shut down for night.

12/17/81 - Ran pump & rods as follows: 1" X 10' combination sand screen & gas anchor, 1-1/2" X 2" X 18' Harbison Fischer single valve no loc plunger bottom hold down pump, 192 3/4" rods, 75 7/8" rods, 7/8" X 4' pony rod & 1-1/4" X 22' polish rod. Seated pump. Spaced well & set rods on clamp.
