- ND wellhead & NU BOP.
- Release tubing from pkr. POOH with tubing.
- Perforate Strawn formation from 9,824'-38' with 2 spf (28 holes). Correlate to Schlumberger Compensated Neutron-Formation Density log dated January 27, 1982.
- RIH with 4-1/2" Lok-Set pkr & set at 9,750'.
- Circulate well with pkr fluid.
- ND BOP & NU wellhead.
- Swab well in to flowing completion and production test Strawn formation.
