T.D. 355' Surface Rock. Prep to drill ahead. MIRU a rotary and spudded 17-1/2" hole @ 1503 MDT on 6-16-85 and drilled to a T.D. of 355' in Surface Rock. Ran and set 2 jts. (74.73') 13-3/8" OD 48# and 6 jts. (260.27') 13-3/8" OD 54.5# casing @ 352' and cemented w/300 sacks of TLW w/2% CaCl₂ + 0.25# Flocele and 15# Hyseal/sack and 200 sacks of Class C w/2% CaCl₂ cement. PD @ 1730 MDT on 6-17-85. Cement did not circulate to the surface. WOC 5 hrs. Ran 1" tubing in annulus and tagged cement @ 320'. Cemented through 1" tubing w/80 sacks of Class C w/2% CaCl₂ cement. TOOH. WOC 2 hrs. Tagged cement @ 250'. Cemented 2nd stage w/100 sacks of Class C w/4% CaCl₂ cement. TOOH. WOC 2 hrs. Tagged cement @ 140'. Cemented 3rd stage w/100 sacks of Class C w/4% CaCl₂ cement. TOOH. WOC 2 hrs. Tagged cement @ 90'. Cemented 4th stage w/100 sacks of Class C w/4% CaCl₂ cement. TOOH. WOC 2 hrs. Tagged cement @ 70'. Cemented 5th stage w/150 sacks of Class C w/4% CaCl₂ cement. TOOH. WOC 2 hrs. Tagged cement @ 55'. Cemented 6th stage w/20 sacks of Class C neat. Circulated 10 sacks of cement to the surface. WOC 18 hrs. Tested 13-3/8" casing to 600# for 30 min. - OK.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
