RIH w/OE'd drill pipe of spotted a 170 sack Class H w/3# silica flour/sack cement plug @ 10,707' - 10,260'. Tagged top of the cement plug @ 10,238' and drilled out cement to 10,450'. Ran and set 264 jts(10,409.46 of 5-1/2" OD 17# N-80 casing @ 10,426' and cemented w/1160 sacks of Pacesetter Lite w/0.25# celloseal and 0.5 of 1% CF-1/sack + 300 sacks of Poz H (50-50) w/3# salt and 0.3 of 1% CF-9 sack cement. PD @ 1000 on 8-01-85. Cement did not circulate to the surface. WOC 4 hrs. Ran temp. survey. TOC @ 4800'. ND BOP's, set slips, CO casing and NU well head.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
