Hallwood Petroleum, Inc. worked on this well from 1/26/95 to 1/29/95. This work consisted of pulling an RBP (retrievable bridge plug) at 8910' (set on 10/7/93), lowering the tbg & pmp to 8999' and commingling oil production from the First Bone Spring (7522-32') and Second Bone Spring (8966-88'). A Form 3160-4 is also included.

NOTE: Oil & gas production from 10/15/93 to 1/25/95 is from First Bone Spring Zone @ 7522-32'. Oil & gas production from 1/29/95 to present is from First Bone Spring (7522-32') and Second Bone Spring (8966-88').
