07-19-90: Notified Mr. Dale Carpenter with BLM prior to spud. Spud 12- $\frac{1}{4}$ " hole @ 10:00PM, 7-19-90. Lost circulation at 85'. Drilled to T.D. with no returns. T.D. 12- $\frac{1}{4}$ " hole @ 5:00AM, 7-20-90.

07-20-90: Ran 10 Jts. 8-5/8"OD, 24#, K-55, ST&C casing, 417.84' set @ 424.92'. Pumped 25 bbls. fresh water without returns. Cemented w/250 Sxs. class "C" cement + 2% CaCl₂, mixed @ 14.8#/gal. Cement did not circulate. Did not bump plug, plug down @ 10:00AM. Did not have flow back. WOC 6 hours. Ran temperature survey. Found top of plug inside @ 322' and top of cement on outside @ 65' from surface - BLM witnessed. Ran 1" Tbg outside and tagged top @ 64'. Pumped 35 Sxs. class "C" cement + 4% CaCl₂, POH w/1" Tbg. WOC 2 hours. Reran Tbg to 46' & broke circulation. Pumped 115 Sxs. class "C" Cmt. + 2% CaCl₂, circulated 20 sxs. good cement. Witnessed by Kathy Green w/the BLM. Pulled 1" Tbg. Backed out landing joint. Nippled up head, BOP & choke manifold. Tested manifold, blind rams & pipe rams to 1000 psi for 30 min. - each held.

07-21-90: Drlg. Cmt., plug & shoe. Now drilling 7-7/8" hole @ 425'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
