08/01/90: Depth 3,195'. Slope Tests: 2,815'-4°, 2,969'-4°. Drlg. break 3,175'-3,180'. 7 Units gas - Circ. Samples.

08/02/90: Drlg. break 3,217'-3,230'. Circ. samples. Slope Test: 3,370'-3°. T.D. 7-7/8" hole @ 3,375' @ 7:45PM, 8-2-90. Circulated & conditioned hole. Rigged up Halliburton Logging Service. Commenced running Multi Shot Bottom Hole location Survey.

08/03/90: Finished running deviation survey. Ran Sonic & Dual Laterolog. Calculation of bottom hole location: 97'-S89°40"E. Called BLM Mrs. Russel. Ran 103-Jts. 4-1/2", 11.6#, J-55, LT&C casing, 3,367.20' set at 3,373.20' KBM. Rigged up Halliburton. Pumped 10 bbls. fresh water followed with 650 Sxs. Halliburton Lite + 1/4# flocele + 15# salt/sx. mixed at 12.7#/gal., & followed w/250 Sxs. Premium Plus 50/50 Poz-mix "A" Cement + 2% gel + 5# salt/sx., mixed @ 14#/gal. Displaced w/51.6 bbls. fresh water. Plug down @ 12:08AM, 8-4-90. Bumped plug w/400 psi over pumping pressure 1,100 psi. Cement did not circ. to surface. Set slips, nipped down & cut off 4-1/2" Csg (50,000# on slips). Released rig @ 4:00AM, 8-4-90. BLM did not witness.

08/04/90: Ran Temperature Survey: Found top of cement @ 420' on the outside & 3,320' on the inside. The 8-5/8" csg shoe is @ 424.92'. Welded cap on 4-1/2" csg. Mr. Adam Salameh w/BLM said cement top was okay.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
