08/17/90: SITP 10 psi. TIH w/swab, found fluid level @ 2,500'. Made 4 swab runs from S.N. @ 3,142' & recovered 2.7 bbls. wtr., 30 bbls. under load. RU Dowell. Fraced well with 72,420# of 12-20 mesh sand. Treated at Avg. Press. of 2,100 psi @ 10BPM, Max. Press. 2,320 psi. ISIP 1,400 psi, 5 Min. 1,258 psi & 15 Min. 1,167 psi. Total load to recover: 740 bbls.. 4 hours SIP 510 psi. Opened well up on choke, bled to 20 psi in 15 min., flowed well for 1½ hrs. & recovered 46.50 bbls. wtr.. S.I. well for 1½ hrs., S.I. pressure increased to 115 psi, re-opened well on 3/4" choke and left flowing to tank. 693.50 bbls. under load.

08/18/90: Well dead, flowed 32 bbls. overnight. RU swab, found fluid level @ 100'. Made 5 swab runs and sand caught swab @ 800', could not go deeper. Opened bypass on Pkr. & unset. POH w/Tbg. & Pkr.. Shut down. 642 bbls. under load.

08/19/90: S.I.

08/20/90: TIH w/S.N. & Tbg. Tagged sand @ 3,198'. RU reverse unit. Loaded hole with 8 bbls. Wtr., circulated & washed down to 3,303' (105' sand). Circ. on bottom for 30 Min., pulled Tbg to 3,143'. Started swabbing w/fluid level @ 100', swabbed for 5½ hrs., fluid level @ end of day @ 1,300'. Recovered 175 BW, no oil, gas or sand. 475 bbls. under load.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
