Rig up Pulling Unit - Circulate hole clean to 6,350'.

Run Bond Log to check cement job. If cement good over interval 6,100' to 6,234' run Compensated Neutron-Gamma Ray Log. Set Cast Iron Bridge Plug at approximately 6,325' w/2 sacks cement on top of it. Perforate interval approximately 6,240-7,234' - 2 holes/ft. Go in hole with 2 3/8" tubing & packer. Will set packer at approximately 6,100'. Acidize perforated interval with 5,000 gallons acid plus ball sealers. Swab test zone.
