Disposal of Salt Water From Federal Wells

Conditions of Approval

Approval of the salt water disposal method is subject to the following stipulations:

1. That this agency be notified of any change in your method or location of disposal.
2. Compliance with all provisions of NTL-2B.
3. That this agency be notified of any spill or discharge as required by NTL-3A.
4. That this agency reserves the right to modify or rescind approval whenever it determines that continued use of the approved method may adversely affect the surface or subsurface environments.
5. That all aboveground structures be painted sandstone brown, Federal Std. 595-20318, or 30318, within 90 days if you have not already done so.
