8-24-91. Bumped plug to 2000 psi, released pressure, float held okay. Circulated 250 sacks. WOC. Drilled out 11:00 AM 8-25-91. WOC 20 hrs, 5 mins. NU and tested to 1000 psi for 30 mins. Reduced hole to 7-7/8". Resumed drilling.
