Pogo Producing Company perforated the Delaware interval 6736' - 6760' 2 spf w/ 4" casing gun 48 .41" holes. This zone was treated w/ 1000 gals 7-1/2% NeFe HCl acid and frac'd w/ 36,000 gals 135 X/Link pad and propped w/ 36,000# 16/30 Ottawa sand. Both Delaware intervals, 6736' - 6760' and 6960' - 6986' were then combined and put on rod pump.
