On 9/25/92, we set 4,395' of 8 5/8" 32# ST&C intermediate casing in an 11" open hole.
We pumped the following cement slurries:

Lead Slurry = 2500 sks 65:35 (Class H:Poz) + 6% gel + 15% salt + 0.25 lb/sk cellophane flake

Tail Slurry = 200 sks Class C + 2% CaCl2 + 0.25 lb/sk cellophane flake

Cement was circulated to surface (218 sks). The BLM was notified of the job, but no witness was present.
