On 10/2/92 we set 8,400' of 5½" 15.5 & 17.0 LT&C production casing in a 7 7/8" open hole. The production casing was cemented in two stages with a DV tool set at 5,748'. We pumped the following cement slurries:

1st Stage = 525 sks Silica Lite + 3% salt + 0.7% Fluid Loss Additive + 0.25 lb/sk cellophane flake

2nd Stage = 400 sks 65:35 (Class H: Poz) + 6% gel + 0.25 lb/sk cellophane flake (lead)
100 sks Silica Lite + 3% salt + 0.7% fluid loss additive + 0.25 lb/sk cellophane flake (tail slurry)

The 1st stage circulated cement to the pit (66 sks). Estimated top of cement on the 2nd stage was 3,500'. The BLM (Kathy) was notified of the job, but no witness was present.
