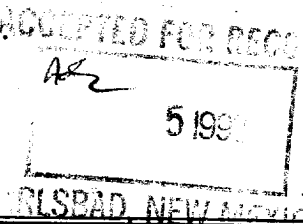

This well was completed in the Delaware as follows:

- 10/13/92 Ran cement bond log. Logs showed good bond. The Delaware was perforated 1 spf from 8006'-8046'.
- 10/14/92 Acidized the perfs with 2650 gals 15% NeFe HCl Acid + 60 ball sealers. Swabbed well down and prepared to frac.
- 10/17/92 Fractured the Delaware perfs with 15,000 gals linear gel + 25,000 gals x-linked gel + 63,125 lbs 20/40 sand. Flowed well to pit until dead.
- 10/18/92- Swabbed well and tested. Flowed well to frac tanks.
- 10/20/92
- 10/21/92 Opened well to the battery.
