On 1/14/93, we set 8340' of 5 1/2", 15.5 and 17.0 ppf production casing in a 7 7/8" open hole. The casing was cemented in two stages with a DV tool set at 5705'. We pumped the following cement slurries:

1st Stage: 575 sks Silica Lite + 3% salt + 0.6% fluid loss additive + 1/4 lb/sk cellophane flakes (cement was circulated to surface - 80 sks)

2nd Stage: 150 sks 35:65 (Poz:Class C) + 6% gel + 1/4 lb/sk cellophane flakes
400 sks Class C + 4% gel + 1/4 lb/sk cellophane flakes

The estimated top of cement is 2500'. The BLM was notified prior to pumping the job.
