This new well was spudded at 22:00 hours on 10/21/92. The BLM was notified prior to drilling.

On 10/23/92, we set 845' of 13 3/8", 48 ppf Wildcat 40 LSS (ST&C) surface casing in a 17 1/2" open hole. The casing was cemented with the following cement slurries:

Lead = 400 sks 65:35 (Class C:Poz) + 6% gel + 2% CaCl<sub>2</sub>Tail = 200 sks Class C + 2% CaCl<sub>2</sub>

We circulated 40 sks of cement to the pit. The BLM was notified prior to the job and arrived on location when we finished pumping.
