This new well was perforated and stimulated in a second Delaware interval as follows:

11/13/92 The Delaware was perforated from 8052' - 8070', 2 JSPF.

11/14/92 The well was swabbed down and we prepared to frac via 5 1/2" casing.

11/15/92 The Delaware perfs were fraced with 37,132 gals gelled KCl water + 15,875 lbs of 20-40 sand. The well was open to the pit for forced closure immediately following the frac.

11/16/92 Well was open to the test tank. Test results will be submitted per Form 3160-4 as soon as they are available.
