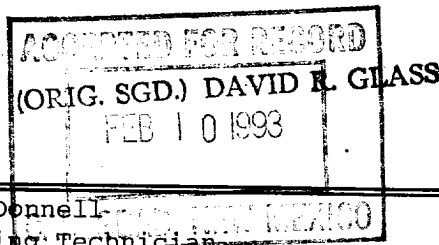
We stimulated additional Delaware perfs in this well as follows:

1/29/93 - Perforated the Delaware from 8,020' - 8,064' (88 holes).

1/30/93 - Acidized the perfs with 2,500 gallons 15% NEFE HCl acid + ball sealers.

2/4/93 - Fraced the Delaware perfs with 51,240 gallons gelled 2% KCl water + 31,625 lbs 20/40 sand. The well was opened immediately following the frac for forced closure flowback.

Currently, we are recovering the load water and testing. Test results will be provided to the BLM as soon as they are available.
