This new well was spudded on 11/25/92. On 11/26/92, we set 830' of 13 3/8", 48 ppf Wildcat 40 LSS STC surface casing in a 17 1/2" open hole. We pumped the following cement slurries:

450 sks 35:65 (Poz:Class C) + 6% gel + 2% CaCl2
200 sks Class C + 2% CaCl2

Cement was circulated to surface (115 sks). The BLM was notified prior to running pipe and cementing.
