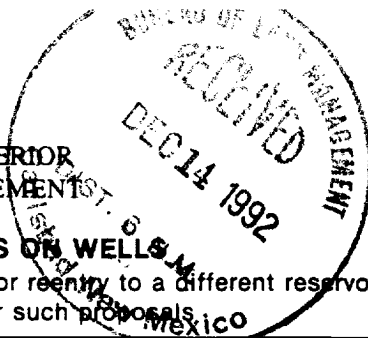

On 12/2/92, we set 4424' of 8 5/8", 32 ppf intermediate casing in an 11" open hole. The casing was cemented as follows:

1. Lead Slurry = 2150 sks 35:65 (poz:Class C) + 6% gel + 14 lbs/sk salt + 1/4 lb/sk cellophane flakes

2. Tail Slurry = 200 sks Class C + 2% CaCl2 + 1/4 lb/sk cellophane flakes

Cement was circulated to surface (350 sks). The BLM was notified (Duncan Whitlock) at 1200 hours on 12/2/92.
