On 11/5/92, we spudded this well at 4:00 p.m. On 11/7/92, we set 849' of 13 3/8" 48 ppf Wildcat 40 (LSS) STC surface casing in a 17 1/2" open hole. The casing was cemented with the following slurries:

1. Lead Slurry = 450 sks 35:65 (Poz:Class C) + 6% gel + 2% CaCl₂
2. Tail Slurry = 200 sks Class C + 2% CaCl₂

We circulated 120 sks of cement to surface. The BLM was notified when the well was spud and surface casing was to be run in the hole.
