On 11/24/92, we set 8,328' of 5½" 15.5 & 17.0 ppf, K-55 production casing in a 7 7/8" open hole. We cemented the casing in two stages with the following cement slurries:
(DV tool was set at 5,712')

1st Stage: 500 sks Silica Lite + 3% salt + 0.6% fluid loss additive + ¼ lb/sk cellophane flakes (Circulated 95 sks to surface).

2nd Stage: 550 sks 35:65 (Poz:Class H) + 6% gel + ¼ lb/sk cellophane flakes
100 sks Class C

Estimated top of cement = 2,500'. The BLM was notified at 20:00 hours on 11/23/92.
