We stimulated another Delaware interval in this well as follows:

12/18/92 We perforated the Delaware from 7962' - 8046' (84 holes)

12/20/92 The perfs were acidized with 2500 gals 15% NEFE HCl acid and 125 ball sealers.

12/22/92 The perfs were fracture stimulated with 59,270 gals gelled 2% KCl water and 59,000 lbs 20/40 sand. The well was opened to the pit for forced closure flowback immediately following the frac.

Currently, we are recovering the load and testing. Test results will be reported as soon as possible.
