This new well was spud at 1800 hours on January 15, 1993. On January 18, 1993, we set 835' of 13 3/8", 48 ppf surface casing in a 17 1/2" open hole. The surface casing was cemented with:

450 sks 35:65 (Poz:Class C) + 6% gel + 2% CaCl2

200 sks Class C + 2% CaCl2

Cement was circulated to surface (146 sks). The BLM was notified prior to pumping.
