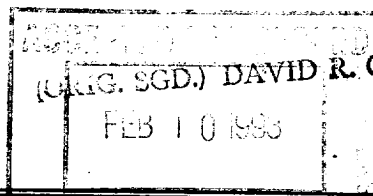
13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. On 1/31/93, we ran 8425' of 5½", 15.5 & 17.0 ppf production casing in a 7 7/8" open hole. The casing was cemented in 2 stages with a DV tool at 5710'. We pumped the following cement slurries:

1st Stage = 525 sks Silica Lite + 3% salt + 0.6% fluid loss additive
(160 sks circulated to the pit)

2nd Stage = 225 sks 65:35 (Class C:Poz) + 6% gel + ¼ lb/sk cellophane flakes
400 sks Class C + 4% gel

Estimated top of cement = 2500'. The BLM was notified prior to the job.
