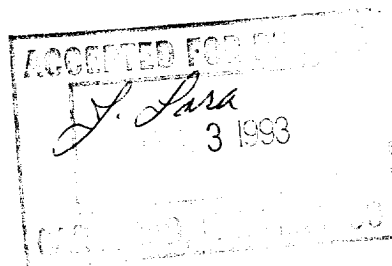

13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. If well is directionally drilled give subsurface locations and measured and true vertical depths for all markers and zones pertinent to this work.)*

On 3-12-93, we perforated the Delaware formation from 8136' - 8228' (100 holes) and acidized the new perfs with 2000 gals 15% NEFE HCl acid via tubing. Following the acid job, we released the packer and pulled the tubing. Then, we fraced the formation via 5 1/2" casing at 30 bpm with 46,200 gals gelled salt water and 34,000 lbs 20/40 mesh sand. The well was opened immediately following the frac for forced closure flowback. Currently, we are recovering the load and flow testing the well. We plan to perforate additional Delaware perfs and to frac again before submitting a completion report.
