2-11-93: Depth 608'. RU and ran 14 jts 13-3/8" 48# H-40 ST&C casing and set at 607'. Cemented w/ 500 sx C1 C + 4% gel + 2% CaCl<sub>2</sub> + 1/4# celloflakes. Tail w/ 300 sx C1 C + 2% CaCl<sub>2</sub>. Plug down at 2:10 p.m. Circ 150 sx to pit. WOC. Cut off casing and weld on head.

2-12-93: WOC total of 24 hours. Test casing to 600 psi - okay. TIH and resume drilling operations.
