Yates Petroleum Corporation proposes to drill and test the Delaware and intermediate zones. Approximately 500' of surface casing will be set and cement circulated. An intermediate string will be set at approximately 4200' and cement circulated. A second string will be run to TD and tied-back to the 8 5/8" casing. If commercial, production casing will be run and cemented with adequate cover, perforated and stimulated as needed for production.

MUD PROGRAM: Spud mud to 500'; Brine water to 4200'; Brine to TD.

BOP PROGRAM: BOP's will be installed at the offset and tested daily for operational.
