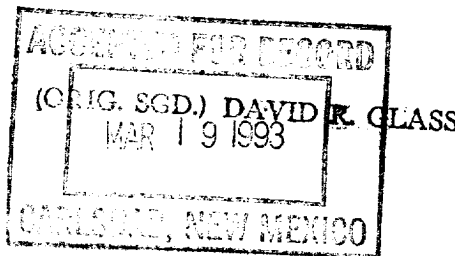

We spudded this new well on 3/1/93 at 2030 hours. On 3/3/93, we set 825' of 13 3/8" surface casing in a 17 1/2" open hole. The casing was cemented to surface as follows:

450 sks. 35:65 POZ:Class C + 6% gel + 2% CaCl2 + 1/4 lb/sk cellophane flakes

200 sks Class C +2% CaCl2 + 1/4 lb/sk cellophane flakes

We circulated 50 sks to surface. Calculated top of cement is surface.
