On 4/22/93, we set 8340' of 5 1/2" K-55/J-55, 15.5 and 17.0 ppf production casing in a 7 7/8" open hole. We cemented the casing in two stages with a DV tool set at 5721'. We pumped the following cement slurries:

1st Stage = 475 sx Silica Lite + 3% salt + 0.6% fluid loss additive + 0.3% dispersant + 0.2% sodium metasilicate + 1/4 lb/sk cellophane flakes

2nd Stage = 200 sx 35:65 (Poz:Class C) + 6% gel
300 sx Class "C" + 4% gel + 1/4 lb/sk cellophane flakes

No cement was returned to surface on either stage. On the first stage, we lost returns 20 bbls before we bumped the plug. We regained returns when we opened the DV tool. A cement bond log will be run to determine the cement tops.
