Acidize perfs with 1500 gals 7-1/2% HCL. Frac with 53,000 gals. X-L gel + 44,000# 20/40 ottawa sand.

Retrieved RBP @ 7800' & combined zone 7722'-7752' with 7821'-7913'. Produce thru 2-7/8" tubing & packer set @ 7680'.
