Cmt w/375 sx Class "C" + 2% CaCl₂ (14.0 ppg, 1.5 ft³/sx) and 375 sx Class "C" + 2% CaCl₂ (14.8 ppg, 1.32 ft³/sx). Disp w/FW. PD @ 2045 hrs 7/10/93 w/500 psi. Full returns. Float held. Circ 423 sx cmt to pit. WOC. Cut-off 13-3/8" csg and weld on csg hd.

7/13/93 - 7/18/93 Drld 12-1/4" hole to 3181'. Ran 69 jts (3200') 9-5/8" K-55 LT&C 8rd NSS csg. Set FS @ 3181'; FC @ 3130'. Cmt w/1900 sx Prem Lite + 15#/sx salt + 1/2#/sx FC (11.9 ppg, 2.06 ft³/sx) and 200 sx Prem Plus + 2% CaCl₂ (14.8 ppg, 1.32 ft³/sx). PD w/1550 psi @ 1300 hrs 7/16/93. Float held. Full returns until end of ppg disp and then partial returns. Circ cmt-colored water to surf - no whole cmt. PU BOP. Fill 13-3/8" x 9-5/8" annulus w/pea gravel while WOC (w/BLM approval). ND, set 9-5/8" slips, cut-off 9-5/8" csg and install csg spool. Test seals to 2000 psi. NU BOPs. Test BOPE, chk man and lines and valves to 5000 psi, hydril to 3500 psi. Install WB. GIH and test csg to 1500 psi. DOC.
