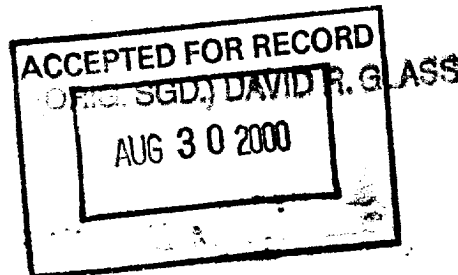
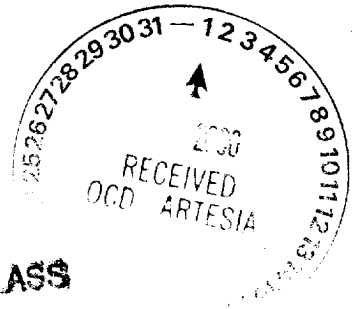

1. MIRU WOU. POOH with completion string
2. Set CIBP @ 12,627'. Tested to 2000 psi. Dump 30' cement on top. New PBTD @ 12,597'.
3. RIH w/mill on 2 7/8" WS and redressed PBR @ 11,109'.
4. Set Smith CLT liner top isolation packer on top of liner hangar @ 11,075'.
5. RIH with 4 1/2" WS for frac job.
6. Perforated 11,398'-11,585' (selective) 2 spf 60° phasing 0.300" holes.
7. Frac well with 540,633 gals of slickwater and 91,187# PR 6000 RCS.
8. Unloaded well and flow test for 5 days. SWI.
9. RIH with HES 'BWB' pkr and set @ 11,300'.
10. POOH with 4 1/2" WS. RIH with latch assembly on 2 3/8" 4.7# L-80 CS Hydril tbgs.
11. Unloaded well and turn to sales.
