13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. If well is directionally drilled, give subsurface locations and measured and true vertical depths for all markers and zones pertinent to this work.)

We spud this new well on 7/16/93 at 1530 hrs. On 7/17/93, we set 875' 13 3/8" surface casing in a 17 1/2" open hole. The casing was cemented to surface with the following cement slurries:

450 sx LITE (35:65) + 6% gel + 2% CaCl2 + 1/4 lb/sk cellophane flakes
200 sx Class "C" + 2% CaCl2 + 1/4 lb/sk cellophane flakes

We circulated 30 sx of cement to the pit. After waiting on cement, we commenced drilling the intermediate hole. On 7/22/93, we set 4363' of 8 5/8" casing in an 11" open hole. The casing was cemented to surface with the following cement slurries:

1500 sx LITE (35:65) + 6% gel + 15 lb/sk salt + 1/4 lb/sk cellophane flakes
200 sx Class "C" + 2% CaCl2 + 1/4 lb/sk cellophane flakes

We circulated 90 sx of cement to the pit.

GENERAL INSTRUCTIONS
