On 7/29/93, we reached TD of 8350' in this new well. On 7/30/93, we set 8350' of 5 1/2", 15.5 and 17.0 ppf, K-55 LT&C production casing in a 7 7/8" open hole. The casing was cemented in two stages with a DV tool set at 5494'. We pumped the following cement slurries:

1st Stage = 550 sx Silica Lite + 3% salt + 0.6% fluid loss additive
2nd Stage = 400 sx Class "C" + 4% gel + 1/4 lb/sk cellophane flakes

We circulated 55 sx of cement to the pit on the 1st stage. The estimated TOC on the 2nd stage is 4150'.
