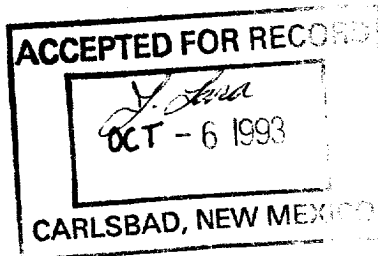

On 8/9/93, we selectively perforated the Lower Brushy Canyon with a 4" casing gun from 8004'-8198' (1 spf, 24 total holes). The next day, the perms were acidized with 1500 gals 7 1/2% NEFE acid + 40 ball sealers. On 8-12-93, we attempted to frac, but the job was not completed due to service company equipment failure. We rigged up to frac again on 8/13/93. The well was successfully fraced with 56,868 gals gelled 2% KCl water + 177,000 lbs 16/30 sand. The well was opened to the pit for forced closure flowback.
