On 9/21/93, we perforated the Lower Brushy Canyon from 8045' - 8228' (25 holes, 4" casing gun). The next day, the perfs were acidized with 1500 gals 7 1/2% NEFE acid + ball sealers. On 9/23/93, the new perfs were fraced with 58,450 gals gelled 2% KCl water + 142,500 lbs 16/30 sand and 44,000 lbs 16/30 resin coated sand. Immediately following the frac, the well was opened to the pit for forced closure flowback. On 9/27/93, the well was put to the battery. The the well tested for 99 BO, 143 MCF and 77 BW on 10/11/93.
