On 10/21/93, we spud this new well. On 10/23/93, we set 860' of 13 3/8" surface casing in a 17 1/2" open hole. The casing was cemented to surface with the following cement slurries:

500 sx Lite (35:65) + 6% gel + 2% CaCl₂ + 1/4 lb/sk cellophane flakes
(slurry weight = 12.7 ppg, slurry yield = 1.88 cft/sk)
200 sx Class "C" + 2% CaCl₂
(slurry weight = 14.8 ppg, slurry yield = 1.32 cft/sk)*

On 10/27/93, we set 4370' of 8 5/8" intermediate casing in an 11" open hole. The casing was cemented with the following cement slurries:

1300 sx Lite (35:65) + 6% gel + 15 lb/sk salt + 1/4 lb/sk cellophane flakes
(slurry weight = 12.7 ppg, slurry yield = 2.0 cft/sk)
200 sx Class "C" + 2% CaCl₂ + 1/4 lb/sk cellophane flakes
(slurry weight = 14.8 ppg, slurry yield = 1.32 cft/sk)

We circulated 59 sx of cement to surface.

* On the surface casing we circulated 125 sx to surface.
