On 8-29-93, we reached TD in this new well at 8340'. We ran 8340' of 5 1/2", 15.5 & 17.0 ppf, K-55, LT&C in a 7 7/8" open hole with a DV tool set @ 5600'. The casing was cemented in two stages with the following cement slurries:

1st Stage = 500 sx Silica LITE + 3% salt + 0.6% fluid loss additive + 14 lb/sk cellophane flakes

2nd Stage = 250 sx LITE (35:65) + 6% gel + 1/4 lb/sk cellophane flakes
400 sx Class "C" + 4% gel + 1/4 lb/sk cellophane flakes

The estimated TOC = 2000'.
