13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. If well is directionally drilled, give subsurface locations and measured and true vertical depths for all markers and zones pertinent to this work.)

On 9/8/93, we perforated the Lower Brushy Canyon in this new well from 8036'-8193' with a 4" casing gun (1 jspf). The next day, we acidized the perfs with 1500 gals 15% NEFE acid + 40 ball sealers. On 9/10/93, we fraced the new perfs with 56,950 gals gelled 2% KCl water + 142,500# 16/30 sand and 48,000# 16/30 resin coated sand.* The well was opened for forced closure immediately following the frac. Currently, we are cleaning out the wellbore and testing.

* The frac was pumped via 5 1/2" casing at 30 bpm average rate.
